Illinois Board of Higher Education / Illinois Community College Board Task Force on Campus Sexual Misconduct Climate Surveys Spring 2025

Each higher education institution in Illinois is required by Illinois law (IL ILCS 155/35) to conduct an annual sexual misconduct climate survey of all students. The survey was developed by a Task Force and provided to Elgin Community College (ECC) by the Illinois Community College Board. The purpose of the survey is to gather information about the behaviors and perceptions that current students have related to relationships, sexual experiences, experiences with dating violence, and perceptions about safety at their college or university during the prior 12 months.

The Elgin Community College Student Services Department emailed 11,222 students on January 27th, 2025 and provided an anonymous link to the online survey form. A total of 105 students (1%) completed the survey form in totality before it was closed on March 7th, 2025.

All full-time and part-time students who were at least 18 years or older (as of January 27th, 2025) were invited to respond to the survey. High school students taking dual-credit courses were not included.

Based on guidance from the state of Illinois, to protect students, response options with fewer than 20 responses are identified with "Too few responses" for reporting.
